Summary of my Activities and Future Plans

Since completing my PhD, I have specialized in phenomenology and philosophies of the body. My present research addresses philosophical (mainly phenomenological) perspectives on *embodiment* and its connections to the conceptualization of the subject, especially within continental philosophy and gender theories.

Currently, I am working on proposing a novel philosophical analysis of the experience of labor and childbirth, grounded mainly in feminist phenomenology and using an innovative approach to challenge feminist theory's current discourses and critiques of labor. This study will change how feminist theory understands and relates to childbirth. Moreover, its findings may illuminate not only the question of labor and its effects on parturient women (mainly on their condition as subjects either provided with or emptied of agency), but also significant issues regarding how phenomenology conceptualizes embodiment and embodied subjects.

This project will present a deep, meticulous analysis of some major themes surrounding the problem of subjectivity in labor, themes that include for instance the eroticism of labor, the special temporality in which labor is experienced and the meaning of home-birth. This research will be mainly informed by the theories of thinkers such as Bergson, Beauvoir, Husserl, Merleau-Ponty, and Young, with feminist uses and criticisms of their philosophies at the center of my analysis.
